Policy 8510.01 District Wellness Advisory Committee Policy was updated 7/2017, 1/2020 and the 2021 update is in progress.

Policy 8531 – Free & Reduced Price Meals Policy was updated 10/2016, 5/2017, 1/2020 and 2/2021.

Policy 8550 –Competitive Food Sales Policy was updated 2014, 3/2015, 1/2020, and the 2021 update is in progress.

## Section 3: Model Policy Comparison

A required component of the triennial assessment is to utilize the Rudd Center’s Wellness School Assessment Tool (WellSAT) for comparison of the Local Wellness Policy to a Model Wellness Policy. The WellSAT includes 67 best practice policy items related to nutrition education; nutrition standards for foods; physical education and activity; wellness promotion and marketing; and implementation, evaluation, and communication. The comparison identified policy strengths and areas for improvement.

The School District of Greenfield Wellness Policy has many strengths.

All Schools have class/es that help educate the students on the importance of wellness, physical activity and nutrition.

Food Services exceeds in providing USDA compliant breakfast and lunches to all students. We always keep families informed on the availability of free or reduced meals but also keep

students status confidential. Food Service takes great pride in offering students a wide variety of meal items to increase participation.

Food Service is very conscience of the nutritional value of ala carte items.

Physical Education is an important part of each student's day.

School District of Greenfield has a competent group of parents, teachers, students and Administration that develop and reviews the wellness policy on a regular basis.

### **Areas for Local Wellness Policy Improvement**

Nutrition Education with the school food environment is being addressed both in the classroom and educating students in the cafeteria on the consumption of smart snacks.

We are continually working with each school admin team and the teachers on the rules and regulations concerning food and beverages served in classrooms and during afterschool activities. We are also working with the staff on not using food as a reward.

We are working with all staff, students and teachers in regard to developing and updating the wellness policy.

### **WellSAT Scores**

WellSAT scores are calculated for comprehensiveness and strength. The comprehensiveness score reflects the extent to which recommended best practices are included in the policy. The strength score reflects how strongly the policy items are stated. Scores range from 0 to 100, with lower scores indicating less content and weaker language and higher scores indicating higher content and the use of specific and directive language.
